March 13-14, 2009  
OFFICIAL RULES**

1. Items may be entered for judging or for display only.
2. ENTRY FEE: Members judged: \$7.00            Non-Judged: \$5.00
3. Judged entries will be displayed. Non-judged entries will be displayed as space allows.
4. REGISTRATIONS MUST BE COMPLETED/POSTMARKED BETWEEN NOVEMBER 1, 2008 AND JANUARY 19, 2009. Entries postmarked before November 1<sup>st</sup> or after January 19<sup>th</sup> will be returned. Registration forms must be filled out completely. Include two color photographs of each entry. All registrations must include a complete narrative. A narrative is defined as the story of the quilt and techniques used. All persons who worked on the quilt and the source of the pattern **MUST** be credited. **EACH ENTRY MUST BE ACCOMPANIED BY A COMPLETED REGISTRATION FORM.**
5. All quilts entered must have been completed within the last two years.
6. Any FKQG member (in good standing with dues paid by October 2008) may enter cloth quilts that meet the specifications of the designated categories.
7. All quilts must be quilted by hand, machine or both and must be finished.
8. All quilts consist of three layers: top, batting and backing. Tied quilts will not be accepted, except for crazy quilts.
9. The quilt must be constructed by the person(s) named on the registration form.
10. Entries are limited to two entries per participant per category. Six entries total per participant.
11. All entries must be in excellent condition: clean, quilt markings removed, undamaged and odor-free.
12. No cheater cloth or pre-quilted fabrics. Quilts constructed from kits must be identified as such in the registration narrative.
13. No rigid frames, mountings or other special handling requirements may accompany quilts. Quilts must be able to be FOLDED – not rolled.
14. All entries must be labeled in the lower left corner (when facing back of quilt) of the back of the quilt. Labels must include the name(s) of the maker, address, telephone number and quilt name.
15. All quilts entered into the large categories must have a 4" sleeve sewn the full width of the quilt.
16. The insurance company requires the value of each entry to be indicated on the registration form for payment in the event of loss or damage. **ALL QUILTS WILL BE VALUED AT \$200 UNLESS ACCOMPANIED BY A CERTIFIED APPRAISAL FORM AND AN ADDITIONAL PICTURE.**
17. If participant requires additional insurance above the standard amount covered for each quilt, the participant must pay for the additional insurance.
18. If the participant wishes to sell his/her quilt, the participant can incorporate a statement of sale in the narrative **ONLY**. It will not be listed for sale in the program. The quilt must be displayed for the entire show.
19. The Show and Registration chairpersons reserve the right to accept, reject, or reclassify entries.
